

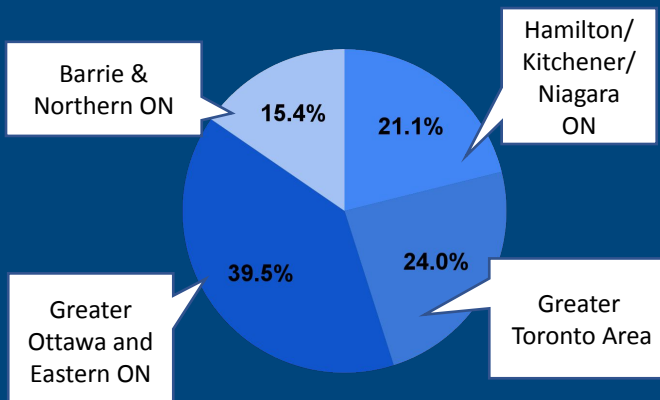

The Nest Capital Mortgage Investment Corp is a pool of carefully selected mortgages in Ontario.

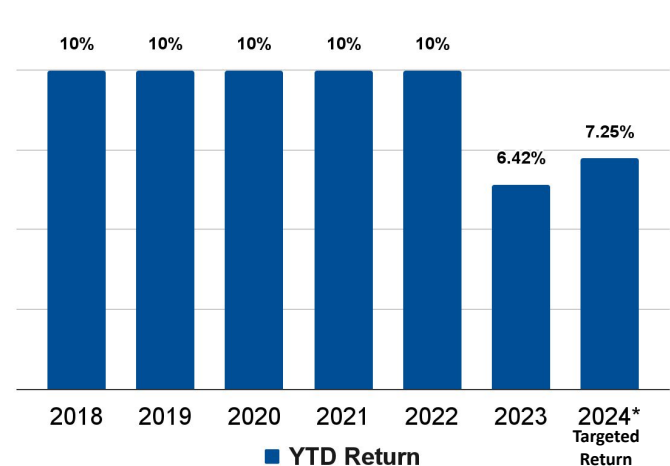
ASSET SECURITY
